

• The S&P 500 and the Nasdaq closed higher on Tuesday for a second straight day after softer-than-expected inflation numbers added to investor optimism from Monday when the U.S. and China announced a trade truce. The S&P 500 rose 0.72%, and the Nasdaq Composite (IXIC) rose 1.61%. Stocks edged up in Asia on Wednesday early morning trade, while the dollar wobbled as relatively benign U.S. inflation data fed into prospects of rate cuts later this year even as investors were still gauging if the worst of the trade conflicts was over. Hong Kong's Hang Seng index (HSI) rose 1.36% in early trading lifted by tech stocks and Shanghai Se Composite Index (SSEC) increased 0.81%. (Reuters)

• TASI recorded an increase of 0.4% (43.7 points), closing at 11,532. Trading value experienced a decline of 12.5% compared to the previous session. The Software and Services sector witnessed the most significant increase, expanding 2.9%. Among the top performers, Saudi Arabia Refineries Co. (SARCO AB) increased 9.9%, followed by Zamil Industrial Investment Co. (ZIIC AB) with a 7.7% uptick, while ARTEX Industrial Investment Co. (ALABDUL AB) rose 4.4%. (Tadawul)

## **Major Economic/Sector News**

- Minister of Communications and Information Technology H.E. Abdullah Alswaha said that Saudi Arabia attracted over \$13 bn in US investments between 2024 and 2025. These investments represent more than 90% of total international investments in artificial intelligence (AI), data centers, cloud services, and the development of national digital capabilities. - NEOM has injected strategic investments worth \$5 bn in the next-generation of artificial intelligence (Al) infrastructure, Rayan Fayez, Deputy CEO at NEOM, said in a panel discussion at the Saudi-US Investment Forum. (Argaam)










