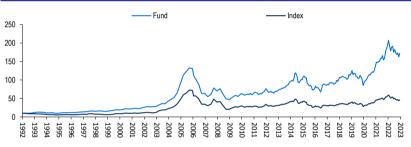

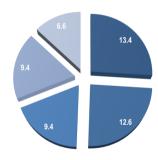
HISTORICAL PERFORMANCE
